- 1. Standish Lane Water Agreement Resolve Discussion When tenant goes in to old Kohl's building consumption rates will change at that time The agreement signed was a sewer agreement not a water agreement. Estimated change in rate is 2% ratio. Improvements to commercial properties would not have a drastic effect on village.
- 2. Building 2 concerns. Foundation in front of building experienced water seepage in to basement. Also water was in middle of wall by floor. 2 classrooms in the lower level requires sprinkler system, estimated cost of system for building would be approx. \$125,000. Plus the cost of a 6" water main line to set up system. Evergreen is looking for a variance "hardship factor". Basement has masonry walls, 4' wide stairways, entrance and exit from each room is within 50' and there is less than 15,000 sq. ft. Application for variance made thru the state.
