payment of it. Talked to Michelle's Land of Learning, the paid ½ of the bill and made arrangements to make sure the other half was paid.

- 5. Oasis Invoice
 - Received a bill from Oasis for fall clean up at Beebe School. Board challenged the validity of the services due to weather conditions at the time the work was completed. Trustee Steiner to follow up with Oasis.
- 6. Traffic issue Maryland Avenue
 - Traffic concerns for Maryland Avenue at Kensington Court. Village resident Jeff Klimek stated that he has heard tire squealing at intersection and fears an accident may happen. Traffic down Maryland Avenue does not follow the set speed limit. Discussion ensued about the possibility of yield signs, stop signs, or additional sheriff's dept. attention to the area. President Mills will talk to Sheriff's Dept. and ask for extra patrol to watch for traffic concerns in this area between 3:00 pm and 5:00 pm.

V. OLD BUSINESS

- 1. Garbage concerns clarification.
 - Trustee Clouthier stated that there have only been a few calls from residents. Several of the residents as the meeting stated that they felt that Johns Disposal was doing a good job. All concerns have been addressed in a reasonable amount of time.
 - Every 3rd Monday is the large item pick up day.
 - All containers must be placed close to the road and spaced properly so that the truck can pick them up.
- 2. Ordinance Codification and adoption guideline.
 - Addressed under IV 2
- 3. Cell Tower and Annexation Stages.
 - The cell tower will happen, it should be up and running by July. There has been a delay in annexing the Taylor complex in to the Village. Alderman of abutting areas are okay with it, Mayor seemed to be okay with it, however city of Racine Administrator is not willing to give up the property without some type of exchange. Village needs some of the land for a possible village park.
