2. CONTRACTS

- Α. Electrical - -2 meters per building C Evans Lighting Design and Wellcraft Electrical. Both bids were within \$192.00 of each other. President Mills made a motion to accept one of the bids. Trustee Steiner asked for more information from village resident John Wilda, who then explained how it may be possible to save some money by adding a watt meter to main electrical panel that would keep track of the usage of electric by each tenant. We would then need to bill the tenant ourselves for their portion of the electric. President Mills expressed that the recommendation he was following was made by WE Energies, and by three other electrical contractors. Discussion whether work needs to be done all at once or could we do them in sections? For salability issues it is recommended we do it all now. WI Energies has committed to do the work from the poles to the buildings at no cost to the village - if work is done a different times we will need to pay WE Energies to remove the 2nd pole and the work that needs to be done.

- 3. Adopt guidelines and application for Planning Commission.
 - -Guidelines were adapted from the State of WI handbook.

5. Rental – Green Space for sports and storage.

-President Mills asked for suggestions on how much we would charge to rent the green space for soccer and other sports during the summer time. Trustee Voss suggested checking with the insurance company to find out if we are covered if something were to happen.

- 6. Loan Outcome Clerk Treasurer
 - Loan from the Board of Commissioners of Public Lands was approved for the refinance of current loan on the Taylor Avenue Complex and cash out for repairs.
 - Loan Amount \$740,000. Pay-off to Johnson Bank which included a 1% prepayment penalty \$660,326.28. Cost to obtain loan through Ehlers \$4,200.00 netting out to \$75,473.72 for updating of the Taylor Complex. The original budget anticipated \$100,000.00 for the updating.

- Interest rate of loan through Johnson Bank was 5.98%, adjustable vs fixed rate of new loan of 3.75%
- 7. Building Elmwood Park's Distinguished Identity Trustee Haas

- Proposal by Trustee Haas to recommend to planning committee to consider and make recommendation to the board regarding welcome signs and their placement at village entrances. Trustee Voss accepted proposal, President Mills 2nd.

- Proposal by Trustee Haas to establish a name for the Village Park, Trustee Clouthier accepted proposal, Trustee Jaeck 2nd. Trustee Haas to add something to the newsletter proposing residents assist in naming the park.

- Proposal by Trustee Haas to have signs made for the park was withdrawn.

- Proposal by Trustee Haas to United States Post Office recognize Village of Elmwood Park as a mailing address. Racine would be secondary address. Trustee Clothier accepted proposal, Trustee Voss 2nd. Village clerk to send letter to USPS with request.

Trustee Haas expressed there may be tax advantages to using Elmwood Park.

Trustee Clouthier expressed there may be tax advantages when registering cars.

 President Mills stated painting has been done, carpeting put in, and we
