IV. NEW BUSINESS

- 1. Village complex Land Use.
 - a. Cell Tower Verizon is looking at leasing a 60' x 60' pad to put up a 120' tower in the Village of Elmwood Park. 50 year lease, \$1,200. Per month will install road to location between buildings 3 & 4, gravel base w/road bond. The Commission made suggestions regarding the location of the tower. Verizon has not provided a site plan for review. President Mills indicated he would report back once he had met with the Verizon representatives.
 - b. New park complex location. Should the property at 3434 Taylor Avenue be sold park must be moved to a location equal in value to that of the current land. Proposal made that the location of new park would be at 3131 Taylor Ave, on the land located in Building 1. Would need survey and appraisal of new grounds for park. Annexation of property when sale to EverGreen School would take place. Projection date end of March 2014. Parking for 25-30 cars.
 - c. New guidelines emailed.

V. OLD BUSINESS

1. Applicants – Plan Commission – two applicants will be invited to attend next meeting for interviews. Applicants are Kelly Stein and Dave Cattoi

2. Old Kohl's lot – abutting property (parking lot & Blue Diamond) are zoned B-2 by the City of Racine.

4. Signs – Hours – B-1/B-2, no 24 hour businesses – illuminated signs to be turned off at night.

5. Permit Clarifications and procedures village. – The only time the \$50.00 Plan Commission fee is collected is when the "footprint" of the property will be changing. No Plan Commission Application is needed for electrical or plumbing work – village inspectors issue fee schedule to home owner – home owner submits to Village Clerk along with check for cost. Village Clerk to then issue permit. Should "footprint" change this requires the standard Plan Commission application with the \$50.00 fee plus 7 copies of all plans submitted with application.
