President Steiner presented a summary for Evergreen Academy Proposal

- 1. Total Cost Value for sale of Taylor Complex is \$1.250 million (approximately 17 acres)
- 2. Book value for Taylor Complex is \$924,000
- 3. Current loan \$584,662
- 4. Expected income from leases/rentals for 2016 is \$181,000
- 5. 3207 Taylor section of 5 acres valued at \$125,000

Discussion held in regards to Evergreen Academy Proposal, Motion Haas Second Klimek that I move the Board accept Evergreen Academy's Offer to Purchase as presented, an offer that includes 13 pages total, 10 of which are form WB-13 marked as signed and dated by Grant Meier on March 4, 2016, contingent on an all clear from the village attorney or an expert Attorney our Village selects.

Motion Haas Second Klimek I move the Board instruct the clerk to inform the Village Attorney that the Board has carried a motion to accept the Offer to Purchase contingent on an <u>all clear</u> from the village attorney or an expert attorney of the village attorney's choice and that the village attorney should give the <u>all clear</u> or <u>not all clear</u>, to include affirmative interpretations that the offer does includes payments to the Village for the cell phone tower will continue into perpetuity regardless of future owners of the property and well as that a covenent indeed included on the property that is permanent, regardless of future owners of the property and that if the attorney notifies the clerk its <u>not clear</u> that the clerk notify the Board as such; and that if the attorney notifies the clerk it's <u>clear</u>, the village president and village clerk are instructed to at once execute the offer so as to render it accepted and the clerk is to at once deliver the executed, accepted offer to Evergreen's, attorney Jeffreyl J. Molinski via U.S. Mail and email as indicated in the offer.
