# NOTICE OF PUBLIC HEARING AND VILLAGE BOARD MEETING VILLAGE OF ELMWOOD PARK, RACINE COUNTY, WI

NOTICE IS HEREBY GIVEN that on Thursday, September 10th, 2020 at 6:30 p.m. at the Village Hall, 3131 Taylor Avenue, Building 3, Racine, WI, a public hearing on Resolution 2020-11 – "A Resolution Amending Section 4.02(4) on Overnight Parking Permits", will be held.

NOTICE IS HEREBY GIVEN that the Resolution shall read:

### 2020 Village Board

A Resolution Amending Section 4.02(4) on Overnight Parking Permits

#### **RECITALS:**

- A. WHEREAS, recent violations within the Village and proper adherence to the Code of Ordinances found a desire for some flexibility regarding parking overnight on Village streets,
- B. WHEREAS, this resolution provides the ability for residents to seek temporary permits through Administration rather than appearing before the Board of Trustees in every case,

## **RESOLUTION:**

NOW THEREFORE BE IT RESOLVED that the Village Board of the Village of Elmwood Park amends section 4.02 to read as follows:

- (4) No person shall park, stop or leave standing any vehicle, whether attended or unattended, between the hours of 2:00 a.m. and 6:00 a.m. on any street or Village right-of-way, in the Village of Elmwood Park, with the following exceptions:
  - (a) Emergency Parking. Medical professionals or law enforcement in emergency situations;
  - (b) Temporary Permit.
    - (1) A temporary permit may be obtained from the Village Clerk at the following cost:
    - A single night (24 hours) of parking, of up to (5) five days for a fee of \$5.00 per night
      - A week (7 days) of parking for a fee of \$30 per week
      - A month (1 calendar month) of parking for a fee of \$50 per month
    - (2) The Village may use its discretion when authorizing these temporary permits to prevent abuse of the allowable timeframes.
    - (3) Each temporary permit must be displayed on or inside the vehicle in question so that it is visible to the public to confirm its authenticity.
    - (4) Permits are not valid during snow emergencies or during times when snow has not been plowed from the designated parking area.
  - (5) Vehicles utilizing such a permit must have current registration and must be operable.
  - (6) The Village Board shall have the authority and discretion to issue a temporary or permanent permit to a resident on the basis of hardship, but only where such hardship has not been solely or primarily caused by the resident.

## (5) Winter Parking:

- (a) Winter parking restrictions are in effect at 11:00 PM December 1 to April 1 at 6:00 AM. During this time, vehicles must be parked on the even side of the street on those nights at 11PM, which bear an even calendar date, and continue to park on that side until 6AM.
- (b) Vehicles must park on the odd side of the street on those nights at 11PM, which bear an odd calendar date, and continue to park on that side until 6AM.
- (6) In no event shall parking be allowed on the grass within the Village of Elmwood Park.
- (7) The forfeiture for the Violation of Section 4.02(1) (6) of this Ordinance shall be \$50.00.
