- Acid Concrete Cleaner
- Ballasts Containing PCBs
- Batteries, Alkaline / Lithium
- Brake Cleaner
- Cleaners w/ *Solvent
- Cooking Oil, Used
- Degreasers
- Driveway Sealer w/ Coal Tar or Petroleum Distillates
- Fertilizer w/ Weed Killer
- Floor Wax Stripper w/ *Solvent
- Fluorescent Light Bulbs, CFLs
- Furniture Stripper
- Gas & Oil Mixture
- Insect Sprays / Baits
- Kerosene
- Laundry Bleach
- Mothballs
- Oil Based Paint
- Pool Chemicals
- Products containing solvents, acetone, xylene and methylene chloride
- Refrigerants
- Stain / Varnish
- Starter Fluid
- Transmission Fluid

UNACCEPTED ITEMS



- Ammunition
- Appliances of Any Kind
- Agriculture Waste
- Auto Parts
- Ballasts w/Out PCBs
- Batteries, Lead Acid
- Business Waste (includes non-profit organizations, churches, etc.)
- Cell Phones
- Commercial Waste
- Compressed Gas Tanks, including Propane & Butane Tanks
- Driveway Sealer, Coal Tar-Free
- Electronics
- Empty Containers
- Fertilizer w/Out Weed Killer
- Fire Extinguishers
- Latex (water based) Paint
- Medical Waste, including Medications & Sharps
- Personal Care Products, such as shampoo, toothpaste, etc.
- Radioactive Waste
- Smoke Detectors

FREQUENTLY ASKED ? QUESTIONS

1. Where do I dispose of my household hazardous waste if I do not reside in one of the seven municipalities listed above?

Residents of Burlington, Union Grove, Dover, & Waterford, should call (262) 342-1181 or visit: <https://www.burlington-wi.gov/339/Clean-Sweep>

All others: Contact your local municipality's village or town hall to inquire.

2. How do I dispose of Latex (water based) paint?

Dry the paint by using paint hardener, oil dry or kitty litter. Throw in trash once dry. City of Racine residents are to drop off dried paint cans at DPW's Pearl Street Bulky Waste site.

3. How do I dispose of the items not accepted at the collection event?

Contact your local municipality for recycling & disposal options or search the internet for local scrap yards, junk removal companies, etc.

4. Where can I dispose of medications or sharps?

5. How do I know if a product contains a *solvent?


Look at the label for the words: flammable, combustible or contains petroleum distillates.
